Specific Conditions/ observations of the DTE's Expert Visiting Team for 2009-10:

- 1. Specific conditions of the year 2008-09 are to be fully complied with.
- 2. Land exclusively for polytechnic to be demarked & documentation to be done properly.
- 3. Present building is inadequate & efforts should be made to increase the built up area.
- 4. Separate ISAP lab is to be established with all necessary equipments & furniture.
- 5. At least 100 books for each course are to be procured & Technical magazine are to be subscribed.
- 6. In mechanical Engg., Mechatronics lab, BCA lab, CAD lab, CNC lab with only 10 PC's are located in the same premises. These are to be separated & 30 more computers are to be added to BCA lab.
- 7. PAL trainer kit, Function generators 4 No.s CCTV -1No.s, stepper motor are to be procured.
- 8. One EC lab is to be setup.
- 9. T V servicing lab is to be established separately. 5 Small 70m 10. PC Hardware lab is to be established separately.
